THE CENTRE on Friday appointed Amit Khare, who exposed the Bihar fodder scam, the secretary of the Information and Broadcasting Ministry, as part of a major bureaucratic reshuffle involving 24 senior IAS officers.

Former Delhi chief secretary MM Kutty and Special Secretary in the Department of Commerce Anup Wadhawan were named Secretaries in the Petroleum and Commerce Ministries, respectively, while former Education Secretary in Sheila Dikshit-led Delhi government, Rina Ray, has been appointed Secretary to the Department of School Education and Literacy.

Khare, who is currently posted in Jharkhand, will take over the charge from NK Sinha, who is set to retire on May 31. The 1985-batch IAS officer had in June 1996 exposed multi-crore fodder scam involving then chief minister of Bihar Lalu

Prasad, when he was with the Deputy Commissioner Chaibasa (now in Jharkhand).

# 'Ceasefire chance to engage misguided youth'

"THE UNILATERAL ceasefire announced by the Centre in Jammu and Kashmir is an opportunity to engage with the youths who have joined militancy and try to bring them back into mainstream," Lt Gen Satish Dua, Chief of Integrated Defence Staff, said in Pune on Friday.

Lt Gen Dua, who is known for his experience in counter-terrorism operations and is currently Chief of Integrated Defence Staff to the Chairman, Chiefs of Staff Committee, was speaking on the sidelines of the valedictory function of academic courses at the Military Institute of Technology at Girinagar in Pune.

When asked about the youths in Jammu and Kashmir joining militancy and also the ceasefire announced by the government, he said: "It is unfortunate to see youths continuing to join militancy. The government has now

these children. After all they own children, they are just misguided youth. This one month is an opportunity to engage with these children and try to bring them back into the mainstream. We hope that there are positive results." Asked about the possibility of aggression from the other side, Lt Gen Dua said, "The order ceasefire has a qualifier. If terrorists attack our forces, we reserve the right to retaliate in self defence."

Speaking about the tri-services integration between Army, Navy and Air Force, Lt Gen Dua said, "For last couple of years, the Prime Minister has given great thrust on integration between three services. Many areas have been identified where this integration is already there and where it needs to be enhanced. Training establishments are being combined. Tri-services exercises are

also being carried out. Also, in the emerging fields like Cyber and Space, tri-services agencies like Defence Cyber Agency and Defence Space agency are in pipeline."
