Place: Ahmedabad Date: September 14, 2017 "Each time the flag is replaced, we incur a cost of about Rs 25,000. While the maintenance of the post was part of the contract, we had not foreseen that we will need to bear so much cost due to frequent damage of the flag. More than the cost, we are also concerned with the protocol of the Flag Code 2002 that has to be kept in mind every time the flag is damaged," said a VMC official.

On September 1, the damage in the saffron stripe of the Tricolour was spotted, following which the VMC brought a tailor to repair the damage. The plan had to be aborted after it was pointed out that the Flag Code does not permit repair of damaged flag.

"We are considering two options. The first option is that we will hoist the flag after the end of monsoon as the weather will be more suitable. The second option is that we will hoist the flag only on weekends and special occasions to prevent recurring damage to the flag. We will decide on it soon," Municipal Commissioner Vinod Rao said.

Meanwhile, the Fire department, which has been given the task for hoisting and maintaining the flag, said that the VMC is yet to give them a new flag. "We noticed damage in the flag after strong winds late on Wednesday night. The flag was immediately lowered in the wee hours as per the protocol. We are waiting for the VMC to give us a new flag so that it can be hoisted again," said Deepak Gunjal, Chief Fire Officer.

The state's tallest Tricolour on the 67-metre f agpost was poisted by Chief Minister Vijay Rupani on August 14.
